

VILLAGE OF ADDYSTON  
ORDINANCE NO. 2010 09

AN AMENDED ORDINANCE APPOINTING WALTER C. WURSTER  
MAGISTRATE OF THE ADDYSTON MAYOR'S COURT  
AND SETTING COMPENSATION

**WHEREAS**, a decision from the Sixth Circuit Court of Appeals questioned the impartiality of a Mayor fulfilling the duties as chief executive of a municipality and also serving as the presiding officer in Mayor's Court; and

**WHEREAS**, the Village has complied with the Sixth Circuit Court of Appeals decision and appointed a Magistrate of the Addyston Mayor's Court; and

**WHEREAS**, the Village desires to set the compensation of the Magistrate and require the Magistrate to maintain a continuing legal education program that qualifies him to serve as Magistrate of the Addyston Mayor's Court; now therefore

**BE IT ORDAINED** by the Council of the Village of Addyston, State: of Ohio:

**SECTION 1.** That Walter C. Wurster, Attorney at Law, Ohio Attorney Registration No, 0018714, duly licensed to practice law in the State of Ohio is appointed the Magistrate of the Addyston Mayor's Court effective August 1, 1999;

**SECTION 2.** That Walter C. Wurster, Attorney at Law, shall be paid Five Hundred Dollars (\$500.00) per month for his duties as the Magistrate of the Addyston Mayor's Court consistent with the prior approval of the prior Village Council and this ordinance shall ratify payments to Walter C. Wurster by the Village Clerk to Walter C. Wurster in the sum of \$500.00 per month.

**SECTION 3.** That Walter C. Wurster, Attorney at Law, shall be paid Two Hundred Fifty Dollars (\$250.00) per court session for special sessions of the Addyston Mayor's Court. Special sessions of Addyston Mayor's Court shall be an court hearings not held once every three weeks. The payment of the foregoing amount shall be for all special sessions of the Addyston Mayor's Court as previously approved by Village Council.

**SECTION 4.** That the Village shall pay the: cost of such continuing legal education necessary for hte Magistrate to preside in Addyston Mayor's Court as prescribed by the Ohio Municipal League Mayor's Court Training or such other governmental organization which provides Magistrate training.

**SECTION 5.** This ordinance is herey declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for siad emergency is the necessity to proceed forthwith and to provide realistic compensation to the Magistrate of the Addyston Mayor's Court and to comply with the request of the audit of the records fo the Village of Addyston to establish the compensation by ordinance..
