

VILLAGE OF ADDYSTON

ORDINANCE NO. 2013-01

**AN ORDINANCE APPOINTING THE VILLAGE SOLICITOR,
PROVIDING FOR AND SETTING COMPENSATION FOR
SAID POSITION AND DECLARING AN EMERGENCY**

WHEREAS, Ohio Revised Code 733.48 provides for the appointment of legal counsel to serve as Village Solicitor for a period not to exceed two years; and

WHEREAS, the Village of Addyston, Ohio, immediately requires the services of an attorney at law to act as Solicitor for the Village; now therefore

BE IT ORDAINED by the Council of the Village of Addyston, State of Ohio:

SECTION 1. That Robert G. Kelly, Attorney at Law, Ohio Supreme Court Registration Number 0002167, be and is hereby appointed to serve as the Solicitor of the Village of Addyston, Ohio, for a one-year period commencing January 1, 2013 and ending December 31, 2013.

SECTION 2. That the annual salary for the Village Solicitor be established at Seventeen Thousand Four Hundred Dollars (\$17,400.00) per year for basic services, payable in equal monthly installments of One Thousand Four Hundred Fifty Dollars (\$1,450.00) per month. Basic services are defined as attendance at Mayor's Court and regular two Council meetings per month.

SECTION 3. That the Solicitor shall receive an addition to the annual salary set forth at Section 2, above, and the Village Solicitor shall earn and be compensated at a salary rate of One Hundred Seventy Five Dollars (\$175.00) per hour in increments of one quarter of an hour for all other legal work performed and not reimbursed from the date of submission of the last statement for legal services, and shall be reimbursed for any out-of-pocket expenses incurred, in all cases in which the Village must enter an appearance in court proceedings in any or all state or federal courts other than the Village of Addyston Mayor's Court, and before state or federal administrative agencies having jurisdiction to hear or dispose of matters or controversies wherein the Village may be a party or may have an interest or other services are required. Further the Village shall make contributions to the Public Employees Retirement System for all monies paid pursuant to this section in 2013. All statements for legal services shall be submitted quarterly. All monies paid to the Solicitor in 2013 shall be considered as part of the Solicitor's annual salary. Any monies due and owing to the Solicitor shall be included in the Solicitor's annual salary for 2013.

SECTION 4. That the Village Solicitor shall faithfully fulfill all duties legally imposed upon him by reason of his office, and as the Mayor and the Village Council may determine from time to time and as may be appropriate and proper.

SECTION 5. That this ordinance is hereby declared to be an emergency ordinance an a measure necessary for the immediate preservation of the public peace, health, safety and general welfare and shall go into effect forthwith. The reason for said emergency is that the Village requires the continuing services of an attorney immediately.
