She reported that she had spoken with a DOT Representative about the problems with US-50 road buckling, the various locations on Route 50 where signage is needed. The State has promised to look at the areas mentioned her telephone conversation with the DOT Representative (refer to video tape/U-tube video). Acting Police Chief Don McWhorter reported that as Mayor Mear had reported Officer Charles Brown has accepted a full-time position with another police agency. He has two police candidates scheduled for interviews that Sgt. Pennekamp will be collaborating with him during the interviews.

**Council Committees** 

Housing/Community Development/Streets - Dan Pillow

Mr. Pillow brought everyone to date on the Park Project he stated that Claire Meyer from HCCD emailed him about the balance of \$30,000 on the park grant, this was due to the work order change from Westside Contractors, he assured Claire that the village will be using it on the park. He mentioned he had spoken to the Attorney General's office a couple of times about the 2018-2019 audit, and he questioned who was contacting the CPA firm to review the recent state audit, Mayor Mear stated she would be contacting the CPA firms.

Finance Committee - Pam Jackson

Reported that the Finance Committee had met on the 16<sup>th</sup> to go over the 2021 Appropriations and the proposed 2022 temporary appropriations, they committee discussed the 2018-2019 findings on the adjustments that needed to be made and therefore the need for the Ordinance to transfer the money from the savings to the Permissive Fund. The committee was recommending a 3% pay increase for the employees and those are spelled out on the Ordinance.

Laws and Contracts – Pam Jackson

She reported that the Laws and Contracts Committee had met twice to revise some of the language in the Personal Policy and Procedure Manual, and to draft some personnel forms that had not been available in the past but are needed due to some of the findings in the 2018-2019 state audit. She stated she would email it to council and would like to get council's input and approval to move forward on adopting it at the next council meeting. And after council's adopts the amended Personnel Policy and Manual the Committee/Council would like to meet with the employees to review the policy so everyone understands it and the rules. Ms. Jackson asked Solicitor Kelly the status of the Darnell Pate hearing. Apparently, they are waiting on the availability of the witnesses. Discussion on the January 1st, 2022, Swearing In of the new council members and the ability to have a council meeting on another date for regular business. A motion was made by Ms. Jackson, seconded by Ms. Anderson for council to meet on Monday, January 10th at 7:00PM for a regular council meeting, no discussion and Roll call vote: 5 Yeas motion carried. As there was nothing further to come before the village council Mr. Pillow made a motion, seconded by Ms. Pillow to adjourn, no discussion and Roll call vote: 5 Yeas motion carried.
